## CALL TO ORDER

## **APPROVAL OF MINUTES**

## SILVER DOLLAR CITY/STONE MOUNTAIN PARK REPORT

Mr. Sonny Horton reported that the summer season is kicking off with recognition of veterans over the Memorial Day holiday weekend. The new laser show content is a significant addition for the season. Mr. Horton discussed recent marketing efforts with radio stations and other media. The movie industry has been using the Park for several films.

Mr. Stan Morrell distributed information about the new laser show which is themed "more music, more lasers, more fun". Seven lasers are now featured instead of three and more lights are included. Terrace seating is sold now in addition to the free lawn seating.

## FINANCE REPORT - YEAR-TO-DATE

Ms. Durham reported that the Finance Committee met earlier and discussed the financial statements through April 30, 2014. Total revenues year-to-date were \$3.5 million and total operating expenses were about \$2.0 million compared to the budget of \$2.25 million. After depreciation the net loss year-to-date is \$500,000 compared to a budgeted loss of \$910,000.

## DEPARTMENT OF PUBLIC SAFETY

Chief Kelley distributed a brochure designed for the SMMA police officers regarding the new firearms law. This brochure was created as a reference for officers and to remind them of the guidelines under the new law. Chief Kelley reviewed the points addressed by the brochure.

The June meeting will be at 11:00 a.m. The committee meetings will be held at 10:00 a.m. The Board will board a bus for a tour of the Park after lunch and the tour will be complete by about 2:30-3:00 p.m.
